MINUTES OF THE REGULAR
MONTHLY COUNCIL MEETING
November 3, 2015

Following are the Minutes of the regular monthly Council Meeting for the City of St. Regis Park, held at 7:00 p.m., Tuesday, November 3, 2015 at 4318 Taylorsville Road, Louisville, Kentucky 40220.

ROLL CALL:

Present: Mayor Brandt Davis; Council Members: Talbott Allen, Bob Graves, Stephen Hoard, Louie Schweickhardt, Eric Shackelford, Frank Wheatley, Cheryl Willett.
Absent: None

MAYOR'S REPORT:

Mayor Davis introduced Mr. John McIntyre of McIntyre & Wooldridge, PSC, Certified Public Accountants, who presented the 2014-2015 Annual Financial Audit Report for the year ending June 30, 2015. There were no significant findings and the required audit information will be published in the December 2015 newsletter. Mr. Graves made a motion to accept the audit report as presented. Mr. Wheatley seconded the motion. The motion passed without dissent.

In keeping with a recommendation from the auditor, Mayor Davis requested Mr. Shackelford work with the City Clerk, Mr. Hodapp, to create a checklist for verifying the monthly bank statements with the accountant's bank reconciliations.

TREE BOARD:

Ms. Jane Ecker, Chairwoman of the St. Regis Park Tree Board, informed the Council the fall tree planting has been completed. To date, 82 trees have been planted in the City of St. Regis Park. Ms. Ecker distributed to Council Members an itemization of the plantings to date by address, resident name and species. Ms. Ecker also advised the green watering bags on the new plantings should be moved inside during the winter months and the water not allowed to freeze. They should then be replaced on the trees once warmer weather returns.

The Tree City USA application for St. Regis Park has been finalized and submitted.

FINANCIAL REPORT:

Mr. Charlie Veeneman, City Accountant, presented the Financial Report for October 2015. General Fund revenues for the month were \$18,248.01 with year-to-date revenues at \$274,943.79. Total expenses for the month were \$20,471.07 with year-to-date expenses at \$101,460.09, resulting in year-to-date revenues over expenses of \$173,474.70.

Road Fund revenues for the month were \$2,662.52 with year-to-date revenues at \$10,271.88. Total expenses were \$0 with year-to-date expenses at \$0, resulting in year-to-date excess revenues of \$10,271.88.

Ms. Willett made a motion to approve the October 2015 Financial Report. The motion was seconded by Mr. Shackelford. The motion passed without dissent.

Mr. Veeneman recommended investing in Certificates of Deposit or other approved securities based upon the receipt of current property tax revenues. Following discussion, Mr. Graves made a motion to close the Park Federal Money Market and Park Federal Checking Accounts of \$201,299.51 and \$5.00, respectively, reinvesting those funds with Fifth Third Securities as appropriate to obtain a higher rate of return. The motion was seconded by Mr. Allen. The motion passed without dissent.

MINUTES:

Mr. Allen made a motion to approve the Minutes of the Regular Council Meeting held on October 6, 2015. The motion was seconded by Mr. Hoard and passed without dissent.

POLICE REPORT:

A letter was presented to the Council from Mr. John M. Aubrey, President of Kentuckiana Law Enforcement (KLE), requesting a rate increase from \$30 per hour to \$32 per hour effective January 1, 2016. KLE provides 100 hours of supplemental police services to the City on a monthly basis. Mr. Aubrey emphasized the current rate had been in effect since 2007, and the nominal rate increase would still be well below the current bill rates in the local market for off-duty police officers patrolling small cities such as St. Regis Park. After Council discussion, Ms. Willett made a motion to approve the increase. Mr. Graves seconded the motion. The motion passed without dissent.

Mayor Davis received a complaint from Mr. Terry Mullaney, Principal of Ascension School, regarding a KLE officer that allegedly pulled over a car in the school parking lot in an unsafe manner. Discussion followed as to what had transpired prior to, during and following the incident in question. It was the consensus of the Council the police officer involved had acted in an appropriate manner.

The KLE Small City Activity Report for the month of October will be published in the December newsletter.

Mr. Allen made a motion to approve the Minutes of the Regular Council Meeting held on October 3, 2015. Mr. Hoard seconded the motion. The motion passed without dissent.

CHANGE IN COURIER-JOURNAL DELIVERY SERVICE

On Monday, November 2, the following notice was included with the delivery of that morning's Courier-Journal:

BRANCHING OUT

If you decide to purchase a live tree to celebrate the holidays this year, there are certain steps that you need to take to keep the tree healthy until it's ready to plant.

- Don't leave your live tree indoors for too long. Leave your tree on the patio, porch, or other sheltered area for most of the holiday season. And then only bring it indoors for a maximum of five days.
- Keep your tree away from fireplaces, heating vents and even television sets. Use smaller electric lights that won't emit much heat.
- Keep the root ball of the tree evenly moist. Do not let it dry out.

Do some advance planning. Have your planting area prepared in case the weather turns too cold or too wet to dig. As long as the soil is not frozen, and is dry enough to work, you've got a window of opportunity to get your planting area prepared. Choose a planting site that is in full sun with a well-drained soil. When you dig the hole fill it with mulch to keep the soil workable and reserve the soil you take out-you may want to put it in a wheelbarrow and store it in the garage to keep it dry and to prevent freezing if we get cold temperatures, otherwise you can just cover the soil with a plastic tarp.


You may choose to purchase a holiday tree in a container or balled and burlaped. Container grown plants are generally the most convenient to get into the ground because they have an established root system within the pot. Plant your container-grown tree at the same level that it is growing in the pot. Look for a watermark on the stem of

the plant to determine its planting depth. If the roots of the plant are so extensive that they are wrapping around the inside of the pot, you should either "tease out" the roots with your fingertips, or use a sharp knife to slash three or four good cuts lengthwise around the root system. Cutting through those encircling roots does not harm the tree; in fact it prevents roots from continuing to grow around which will eventually strangle the tree. Cutting the roots stimulates new root growth.

"Balled and burlaped" describes the root system of the plant. The roots are dug out surrounded by a soil ball. The soil ball is then wrapped by the nursery in burlap. Balled and burlaped trees can be extremely heavy-upwards of 100 pounds.

Your most important task will be to make sure that the newly planted tree is well watered, especially during its first year or two of establishment. If Mother Nature doesn't supply the precipitation, give your newly planted tree a good soaking every 10 days or so.

SHOPPING TIPS

The holidays are here! Whether we're shopping for groceries, angel tree gifts, or a book for the elementary school program, we're all out there during the holiday season. We can often become so distracted by the lists in our heads, kids at our heels, and work left undone that we lose sight of our personal safety. You may have read them before but a refresher is always a good idea. Here are a few things to consider.

Be aware of your surroundings. Look for suspicious persons and unusual activity. Walk with authority. Don't look like a victim.

Make a note where you park. Park near a light pole so that it lights the area should you return in the dark. Have your keys ready.

Don't overburden yourself with too many packages. Take a shopping buddy with you and secure your purchases in your car – concealed. Move your vehicle to another area of the parking lot in case someone was watching you put your packages in your vehicle.

Don't hesitate to ask for a security escort if you feel unsafe. The time it takes to wait for the escort is always worth your safety.

Be aware of strangers approaching you for any reason. At this time of year, con-artists will use lots of different reasons to get your attention away from your belongings.

INFORMATION TO IMPROVE HOMEOWNERSHIP THINGS THAT KILL YOUR CREDIT



Some people take their credit for granted and don't start paying attention to it until they need it. The problem with this is that it could delay if not altogether cause the loan to be denied.

The most common issue is not correcting items on your credit report. A large majority of credit reports have errors but not all of them are critical. Since it takes time to remove them, it is a good practice to review your free credit reports from each -- Experian, TransUnion and Equifax -- once a year at www.AnnualCreditReport.com.

Another problem is making late payments. One 30-day late payment could be enough to cause a borrower to pay a higher interest rate or even be denied a loan. Payments have a due date and even when they allow a few days before a late fee kicks in, if it isn't on time, it's late.

Maxing out credit cards is another big problem. Ideally, a person wants to have an outstanding balance of no more than 30% of their available credit. As the percentage of available credit decreases, the credit score will go down.

Bad credit can not only keep you from getting the loan you want, it can raise your rates on the insurance you buy. In a study released by the Consumer Federation of America, people with good credit paid less than people with average and poor credit. The results indicate that some customers with poor credit scores were charged about twice as much as those with excellent scores.

A prudent idea if you are going to be moving to a larger home is to get pre-approved with a trusted mortgage professional before you sell your current home. Occasionally, sellers find out after they've sold their home that they can't qualify for another mortgage.

Remember, contact your real estate professional to evaluate the opportunities of making a move, and make certain you know the **TRUE VALUE** of your home **BEFORE** listing it for sale.

Independent Auditor's Report

The Honorable Mayor and
Council of the City of
St. Regis Park, Kentucky

We have audited the accompanying financial statements of the governmental activities and each major fund of the City of St. Regis Park, Kentucky as of and for the year ended June 30, 2015, and the related notes to the financial statements, which collectively comprise the City's basic financial statements as listed in the table of contents.

Management's Responsibility for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America; this includes the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

Auditor's Responsibility

Our responsibility is to express opinions on these financial statements based on our audit. We conducted our audit in accordance with auditing standards generally accepted in the United States of America and the standards applicable to financial audits contained in *Government Auditing Standards*, issued by the Comptroller General of the United States. Those standards require that we plan and perform the audit to obtain reasonable assurance about whether the financial statements are free from material misstatement.

An audit involves performing procedures to obtain audit evidence about the amounts and disclosures in the financial statements. The procedures selected depend on the auditor's judgment, including the assessment of the risk of material misstatement of the financial statements, whether due to fraud or error. In making those risk assessments, the auditor considers internal control relevant to the entity's preparation and fair presentation of the financial statements in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the entity's internal control. Accordingly, we express no such opinion. An audit also includes evaluating the appropriateness of accounting policies and the reasonableness of significant accounting estimates made by management, as well as evaluating the overall presentation of the financial statements.

We believe the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinions.

Opinions

In our opinion, the financial statements referred to above present fairly, in all material respects, the respective financial position of the governmental activities and each major fund of the City of St. Regis Park, Kentucky at June 30, 2015, and the respective changes in financial position for the year then ended in accordance with accounting principles generally accepted in the United States of America.

Other Matters


Required Supplementary Information

Accounting principles generally accepted in the United States of America require that the management's budgetary comparison information on page 17 & 18 be presented to supplement the basic financial statements. Such information, although not a part of the basic financial statements, is required by the Government Accounting Standards Board, who considers it to be an essential part of financial reporting for placing the basic financial statements in an appropriate operational, economic, or historical context. We have applied certain limited procedures to the required supplementary information in accordance with auditing standards generally accepted in the United States of America, which consisted of inquiries of management about the methods of preparing the information and comparing the information for consistency with management's responses to our inquiries, the basic financial statements, and other knowledge we obtained during our audit of the basic financial statements. We do not express an opinion or provide any assurance on the information because the limited procedures do not provide us with sufficient evidence to express an opinion or provide any assurance.

Management has omitted the Management's Discussion and Analysis that accounting principles generally accepted in the United States of America has required to be presented to supplement the basic financial statements. Such missing information, although not a part of the basic financial statements, is required by the Government Accounting Standards Board, who considers it to be an essential part of financial reporting for placing the basic financial statements in an appropriate operational, economic, or historical context. Our opinion on the basic financial statements is not affected by this missing information.

Other Reporting Required by Government Auditing Standards

In accordance with *Government Auditing Standards*, we have also issued our report dated October 28, 2015 on our consideration of the City of St. Regis Park, Kentucky's internal control over financial reporting and on our test of its compliance with certain provisions of laws, regulations, contracts and grant agreements and other matters. The purpose of that report is to describe the scope of our testing of internal control over financial reporting and compliance and the result of that testing and not to provide an opinion on the internal control over financial reporting or on compliance. That report is an integral part of an audit performed in accordance with Government Auditing Standards and should be considered in assessing the results of our audit.
