Dear Citizens,

I hope this finds all of you safe and healthy. We have resumed in-person council meetings. Our next council meeting will be at the Jeffersontown Fire House on Taylorsville Rd. at 7 p.m. on Tuesday October 5, 2021.

I wasn't available for the Annual City-Wide Yard Sale, but I heard it was a success. I would like to thank Councilman Louie Schweickhardt for placing the "No Parking Signs" prior to the yard sale.

After Labor Day, I noticed that there was some confusion as to when trash/recycle was going to be collected. Moving forward, we will do a better job of placing any day/date changes in the "Mark Your Calendar" corner on the front page of the newsletter as well as on Facebook, ReachAlert and Blockwatch. Please remember that when holidays occur on Monday, garbage collection is postponed one day until Wednesday. If you have problems with trash collection, particularly with rear door pickup, please contact Councilman Jeff Weis at 548-0522 so that he can track and forward your problems to Rumpke.

As I mentioned in last month's newsletter, Kirk Berry, Paul Fetter and Jack Bilyeu (Board Members at the Upper Highlands Swim Club) joined us at the August Council meeting. They shared the pool's financial hardship with us due to the fact that it couldn't open in 2020 or 2021 because of Covid-19. We see our neighborhood pool as a tremendous asset to the city and want to make sure that it doesn't go away and that it thrives. With that in mind, the City Council passed a proposal at the September meeting to make a grant of \$10,000 to Upper Highlands. The grant is contingent on the swim club offering a free one-day family trial voucher to all St Regis Park households. If the grant is accepted, each address in the city will receive a voucher good for the entire family on any single weekday of the 2022 summer season. In accordance with the grant application, the funds will be used to pay for property taxes, tree removal, and a new pool cover and the money will be paid directly to the vendors that provide those services.

We would like to formally invite anyone who is interested to apply for the City Citation Officer position. The position pays \$550 per month, plus mileage reimbursement and some cell

September 7, 2021

Following are the Minutes of the September 7, 2021 City Council Meeting for the City of St. Regis Park, held at 7:00 p.m. at the Jeffersontown Fire Station #2.

The city accountant, Mr. Charles Veeneman, CPA presented the August 2021 financial report. Mr. Shackelford made a motion to approve the report. Ms. Willett seconded the motion and it passed without dissent.

Mr. Amback made a motion to approve the August 2021 meeting minutes. Mr. Shackelford seconded the motion and it passed without dissent.

Mr. Schweickhardt made a motion to cap the citation officer cell phone reimbursement at \$50.00 per month. Mr. Sanderfer seconded the motion and it passed without dissent.

Mr. Weis made a motion to hire Nathan Jones as the new citation officer. Nathan will serve a 90-day probationary period and other applicants may be considered for the position after the 90-day period. Mr. Shackelford seconded the motion and it passed without dissent.

Mr. Schweickhardt made a motion to approve a \$10,000.00 grant request from Upper Highlands Swim Club. Mr. Shackelford seconded the motion and it passed with Mr. Sanderfer dissenting. The grant is contingent on the swim club offering a free one-day family trial voucher to all St Regis Park households. If the grant is accepted by Upper Highlands, each address in the city will receive a voucher good for the entire family on any single weekday of the 2022 summer season. In accordance with the grant application, the funds will be used to pay for property taxes, tree removal and a new pool cover.

Mr. Weis made a motion to approve the 2nd reading of Ordinance 4, 2021-2022, an ordinance revising the open records request process. Mr. Sanderfer seconded the motion and it passed without dissent.

Mr. Weis made a motion to approve the KIPDA contract for the required reporting and monitoring of the American Rescue Plan funding. Mr. Sanderfer seconded the motion and it passed without dissent.

There being no further business, Mr. Amback made a motion to adjourn. The motion was seconded by Mr. Weis and it passed without dissent. The meeting adjourned at 8:28 pm.



ORDINANCE 3, 2021-2022
AN ORDINANCE AMENDING THE INVESTMENT AND FINANCIAL
MANAGEMENT POLICY FOR THE CITY OF ST. REGIS PARK

Ordinance 3, 2021-2022 amends the City’s existing ordinance chapter relating to investment policies to match changes to Kentucky law. In 2019, the state statutes governing what Cities can invest surplus funds in were updated by the Kentucky State Legislature. After the law passed, the Kentucky League of Cities created a model investment policy that is compliant with the changes. Ordinance 3, 2021-2022 adopts that model policy to update St. Regis Park’s investment policies to the new state law. The undersigned attorney does hereby certify that this ordinance has been summarized for publication pursuant to KRS 83A.060(9). AN ORDINANCE AMENDING THE OPEN RECORDS POLICY FOR THE CITY
OF ST. REGIS PARK

Ordinance 4, 2021-2022 amends the City’s existing ordinance chapter relating to open records policies to match changes to Kentucky law. In 2021, the state statutes governing open records were updated by the Kentucky State Legislature. The primary changes were to increase the time for responses to open records request from 3 to 5 days and to limit the use of the open records law to Kentucky residents. The undersigned attorney does hereby certify that this ordinance has been summarized for publication pursuant to KRS 83A.060(9).
