Greetings everyone, I hope you are having a safe and enjoyable start to fall. I am glad autumn activities have started and look forward to seeing the Halloween decorations and costumes in the coming weeks. Hopefully, we will have nice weather so the kids can have an enjoyable trick-or-treat this year.

If you have been considering a new tree for your yard, I would like to remind you that St. Regis Park offers free tree planting. Please see the "Tree Planting Request Form" in this issue. The deadline to file your application is October 15th, so time is short. Also, if you feel your existing tree needs maintenance the city offers reimbursement up to \$500. Please reach out to the Tree Board for specifics and options available.

At the September city council meeting, some residents in attendance inquired about code enforcement and our ability to issue penalties for unresolved ordinance violations within the city. Our citation officer, Jason Lewis, went over the process for how ordinance violations are handled from the point a violation is detected up to, and including, fines. Jason advised that, after an educational discussion with the property owner, most ordinance violations are remedied in a timely fashion without need for additional action. Unfortunately, unresolved issues are encountered which must be escalated to a fine, as outlined in our ordinances.

Enforcement and collection of these fines can be an expensive and cumbersome legal process. To simplify and ensure resolution of unresolved violations, the city council and I will discuss with our city attorney the creation of a "City of St. Regis Park Code Enforcement Board" at our upcoming council meetings.

Many of our peer cities have these in place already. The proposed board would be made up of at least 3 resident representatives. If this is something you may be interested in joining, we would love to hear

from you, or please attend next month's meeting to get more details. I hope to see you there.

Finally, mark your calendars for the annual "St Regis Park Holiday Party" at St. Andrew United Church of Christ on Browns Lane, on Saturday, December 14th from 4:00 to 6:00 pm. Stop by for some good food, prizes, and see Santa. We look forward to seeing you!!!

Did You Know?

50.01 PLACEMENT, COLLECTION AND REMOVAL

- (A) No garbage, grass or trash shall be placed at the curb side before 3:00 p.m., the day prior to pickup.
- (B) All garbage cans and items not collected shall be removed from the curb side by 7:00 p.m., the day of pickup.
- (C) During the fall of the year, leaves may be placed at the curbside the day prior to pickup after 3:00 p.m., as provided in division (A).
- (D) The placement of garbage, grass, leaves or trash at the curb side shall be at least five feet from the property line.


