Did You Know?

70.01 MANOR OF PARKING

(A) It shall be unlawful for the operator of any vehicle to stop or park the vehicle in a manner other than with its right-hand side toward and parallel with the curb.

(B) No vehicle shall be parked or left standing on any street unless its two right wheels are within one foot of and parallel with the curb, except that on one-way streets where parking is permitted on the left side, the two left wheels are to be within one foot of and parallel with the curb.

70.02 LIMITATIONS OF STOPPING AND PARKING

(A) No person shall stop or park a vehicle, except when necessary to avoid conflict with other traffic or in compliance with the directions of a police officer or traffic control device, in the following places:

- (1) On a sidewalk or on a driveway blocking a sidewalk;*
- (2) In front of a sidewalk ramp providing for handicapped access;*
- (3) Within an intersection;*
- (7) Within 15 feet of each side of the approach to any fire hydrant;*
- (8) Any place the curb is painted red or yellow;*
- (9) In any manner that will affect the normal flow of traffic;*
- (11) In front of any public or private driveway;*
- (12) In the front, side, street side, or rear of a residence, except on a hard surface of asphalt or concrete;*

BRANCHING OUT

September, 20

September, Remember... has such a lovely ring to it—thoughts of cooler temperatures and gorgeous colors to look forward to. The Tree Board thanks those of you who signed up for free canopy trees to be planted in November. One—or actually twenty-one—more bits of beauty to look forward to.

Here are a few reminders as we enter the autumn:

Fall is a great time to have the health of your trees evaluated. As long as leaves are on the trees, an arborist can evaluate whether your trees need feeding, pruning, or other treatments. Use our Reference List, found on the SRP website to use tree services that will allow you to participate in our maintenance reimbursement program.

It's also a good time to check the mulch under your tree—remember the rule of threes! Keep mulch 3 inches from the trunk. 3 inches deep, and three feet in diameter around the tree.

Despite what you may have always thought, leaf raking is mostly optional. If your layer of leaves is pretty thin, just mulch-mow them. Their nutrients will provide free fertilizer for your lawn, help suppress weeds, and improve soil health. If you rake your leaves, they can be helpful mulch in flower beds, or you can compost them. They will also provide shelter for pollinators and beneficial insects. You probably don't, however, want to keep a really thick mat of whole, wet leaves on your lawn all winter.

Finally, if you are kicking yourself for not ordering a tree this year, then mark your 2026 calendar for late July, when we will announce your tree choices for next year. Submit your request by August 15th for November, 2026, planting.
