I would like to thank Cheryl Willett for her efforts again by organizing the event and the other council members who came out to help.

Our new snow removal team has done a great job with the snow and ice we have had thus far with prompt service as soon as events occur. Hopefully we don't have any serious events, but we are ready if needed. Snow is forecasted sporadically for at least the first weeks of January. If accumulating snow is in the forecast, it would be a huge help to everyone if you all could please move your vehicles into your driveway. Vehicles left on the street will be plowed in and create an unnecessary obstacle to safe driving on potentially hazardous streets. Vehicles on the streets during snow events do nothing but reduce our ability to provide two clear lanes.

During our December meeting, our law enforcement representative Sergeant Tulio Tourinho talked with us about recent automobile thefts that have occurred in surrounding neighborhoods in the past 2-3 months. He advised the car thieves are organized in teams and technically efficient with the ability to disable a vehicle's anti-theft features with a laptop in seconds. Typically, but not always, they are targeting newer vehicles manufactured in the past five years. Victims of these crimes who have opened their doors to see what is happening as the crime is in progress have been met with gunfire resulting in a serious injury in one case. Thankfully, officers have caught at least two crews, but we know there will be more. Personally, I don't believe a vehicle is worth anyone's

life. Please call 911 and stay inside your home if you witness something like this happening at yours, or your neighbor's residence.

Finally, the council members and I would like to wish you all the best in the New Year. We hope 2026 is a great one for you and your family!

# Did You Know?

## 92.03 PROPERTY MAINTENANCE STANDARDS

*It is hereby declared to be a public nuisance for any property owner (or other person in control of the property) to keep or maintain property, premises, or rights-of-way adjacent to the premises, in such a manner which causes, or tends to cause, substantial diminution in value of other properties, or which renders such properties as dangerous, or detrimental, or adverse to the health, or welfare, or offensive to the senses of the residents of the city. This includes, but is not limited to, the following conditions, which are hereby declared a nuisance.*

**(B) Walkway obstruction.** *All owners of property abutting a sidewalk shall maintain an unobstructed walkway of at least eight feet in height. Branches or trees and shrubs shall not encroach upon any sidewalk, sidewalk height restriction, nor the 13 feet, six inch vertical clearance required above any roadway.*

**(D) Incomplete projects.** *Any renovation or construction to structures or grounds must be completed through consistent, sustained effort and no such building or grounds under construction or renovation may be allowed to be uncompleted for an unreasonable length of time, given due consideration to the type of project. A period of 120 days without consistent, sustained effort to complete the project will be an unreasonable length of time, without sufficient, specific, written explanation for the delay.*

**(K) Junk; scrap metal, motor vehicles.** *The storage (unless enclosed within a garage) of motor vehicles in an inoperative condition, motor vehicles unfit for further use, automobile parts, scrap metal or junk.*
