Greetings residents and happy June to you all. The neighborhood is now in full bloom and so many yards are really looking great. I want to say thanks to all who put in the effort to maintain their property. This is what keeps our property value higher than similar surrounding communities. St Regis remains a great place to live and raise families because of your hard work.

With property value in mind, I realize many of you have received higher than expected tax increases due to the recent Jefferson County property valuation assessments. Unfortunately, there is nothing we can do as a city to combat this, but I hope some of you did appeal by the May 20th deadline. Property owners over 65 and those with disabilities can apply for a \$46,350 Homestead Exemption on the PVA's website, jeffersonpva.ky.gov. There's both an online form and a printable form on the "Forms & Tools" section of the website. Area Social Security offices and local government centers should have the form, as well.

The annual budget for 2024-2025 was discussed at our May council meeting. Projected revenues and expenditures are holding steady from the 2023-2024 results, so few changes were needed. I'm happy to report that the city council deemed a tax increase unnecessary given the performance of our investments over the past year and the outcome of our budget.

In fact, a motion was approved that lowers the tax rate to \$.076/\$100 of value from \$.095/\$100 of value. The new rate will keep the total amount that homeowners pay consistent with last year. So, even though your assessment may have gone up 25% to 30%, your 2024 St. Regis Park Property Taxes should remain close to the same amount that you paid in 2023.

A resident from Woodward Drive attended the May meeting requesting permission to hold a block party on Sunday June 23rd from 1:00pm to 8:00pm. The requested area consists of Woodward Dr. between the intersection of Ashfield Lane & Woodward to

the intersection of Woodward & Statton. The party was approved by the city council. During this time, through traffic will be diverted around the Statton/Milburn loop. Residents living on Woodward will be able to come and go as usual, emergency vehicles will enter and exit unimpeded. I personally applaud their efforts to foster relationships with neighbors and hope those attending have a great time.

## Did You Know?

#### 90.01 DEFINITIONS

For the purpose of this chapter, the following definitions shall apply unless the context clearly indicates or requires a different meaning.

ABANDON. Abandonment shall constitute the relinquishment of all rights and claims by the owner to the animal. (KRS 257.100(4))

AT LARGE. Off the premises of the owner, and not under the control of the owner or his agent either by leash, cord, chain or otherwise.

OWNER. Every person having a right of property to an animal and every person who keeps or harbors an animal, has it in his care, or permits it to remain on or about the premises owned or occupied by him.

#### 90.02 ANIMALS RUNNING AT LARGE

- (A) No person who is the owner of any animal shall permit it to run at large in any public road, highway, street, lane, or alley, or upon or enclosure without the consent of the owner of the yard, lot, or enclosure.
- (B) The owner of an animal who permits it to run at large in violation of this section is liable for all damages caused by the animal upon the premises of another.

#### 90.03 NOISE DISTURBANCE

No person shall keep or harbor any dog within the city which, by frequent and habitual barking, howling, or yelping, creates unreasonably loud and disturbing noises of such a character, intensity, and duration as to disturb the peace, quiet, and good order of one or more of the inhabitants of two or more separate residences. Any person who shall allow any dog habitually to remain, be lodged, or fed within any dwelling, yard, or enclosure which he occupies or owns shall be considered as harboring the dog.

#### 90.06 REMOVING AND DISCARDING ANIMAL WASTE

- (A) It shall be unlawful for any owner or person in charge of a dog, cat or any other animal to permit the animal to be on public property, or any private property other than that of the owner or person in charge or control of the animal without the permission of the owner of the property, or on any streets, sidewalks or rights-of-way in the city, without the owner or person in charge of the animals to have in his or her possession, a suitable device for the picking up, collection and proper sanitary disposal of the animal feces or manure.
- (B) It shall be unlawful for the owner or person in charge of a dog, cat or any other animal to permit or allow the animal to excrete manure or feces on public property, or on any private property other than that of the owner or person in charge or control of the animal without the permission of the owner of the property, or on any streets, sidewalks or rights-of-way in the city, unless the owner or person in control of the animal immediately removes all feces deposited by the animal and disposes of same in a sanitary manner.

## **BRANCHING OUT**

School's Out... but St. Regis Park Tree School is In Session! Now ten years old, our tree board would like to update new and longtime residents about what the tree board is, why we exist, and how we envision our future.

On January 7, 2014, St. Regis Park established, by ordinance, a Tree Board. Due to the vision of then-mayor Brandt Davis and the city council, the process of maintaining and expanding our current tree canopy began, and the tree board's efforts have been supported by every subsequent council and mayor. We are most grateful.

Looking back on our first ten years, we wanted to evaluate whether we should make any changes to our tree planting policy. To accomplish this, we began with our original values, vision, and mission. The following was our seminal vision and mission statement, created in late 2014 by original tree board members Jane Ecker, Joe Hinkle, and Mary Mattingly, based on the values statement created in our tree ordinance.

#### St. Regis Park Tree Board—Vision, Mission, and Strategies

#### Values of the City of St. Regis Park

The city values trees as an important natural resource

The city values the biological diversity of trees, and their role in providing air, water, and soil protection, filtering pollutants, and providing habitat

The city values well-selected and maintained trees to contribute to property values and decreased energy costs

Therefore, the City of St. Regis Park establishes a Tree Board.

#### Vision Statement of the St. Regis Park Tree Board:

Our vision is a city that has an appropriately full and healthy tree canopy.

#### Mission Statement of the St. Regis Park Tree Board:

The Tree Board and its city arborist support the mayor and city council in providing information, education, and incentives for developing a healthy tree canopy by maintaining existing trees and planting new ones.

As the current tree board and consulting arborist, Cindi Sullivan, look back on our efforts, we are pleased with the addition of approximately 400 new trees since 2015. Early trees planted were almost exclusively large canopy trees. As we built enthusiasm for planting new trees, citizens began to request smaller, more ornamental trees, even arborvitae. In our enthusiasm for the citizens' enthusiasm, we fulfilled many of these requests, During 2020-2022, we were receiving more requests for ornamentals than canopy trees.

While ornamental trees clearly have both aesthetic and environmental value, thereby enhancing the value of all homes in the city, the board wanted to look back at our mission statement and determine whether our current policies were consistent with our original mission.

Since our mission is to "support the mayor and city council in providing information, education, and incentives for developing a healthy tree canopy by maintaining existing trees and planting new ones," we believe our focus should primarily be on large canopy trees. Law Insider defines a canopy tree as "a tree that normally grows to a mature height of 40 or more feet." A tree canopy is defined by the Arbor Day Foundation as "the layer of leaves, branches, and stems of trees that cover the ground when viewed from above." Obviously, the taller and wider the tree, the more it contributes to a shaded city and a healthy tree canopy. Ornamental trees certainly contribute to a healthy tree canopy, but they are not the most important component.

So given that background, the tree board asked the city council whether they thought we should be providing only canopy trees and perhaps splitting the cost of ornamental trees. The council gave us a big vote of confidence in declaring that they wanted us to make that policy decision.

So, using our hearts as well as our heads, we have decided to continue to take requests for ornamentals, at least for the coming year or so. Please keep in mind that we can not always fulfill your very specific tree variety requests. We will do our best to provide trees that are available and appropriate for our region, and that fill the need for us to have variety in our tree species so no disease or weather condition can deplete too many of our trees.

We do, however, also want to remind everyone that our primary mission is to plant canopy trees. In what is fast becoming a world of three warm-to-hot seasons each year, you might want to give some thought to adding canopy trees to your yard, along with perhaps an ornamental for interest.

As always, thank you for helping us Re-Tree the Park!

PS—The tree portion of the SRP website is unavailable. We hope to be able to re-instate it with useful information for our citizens in the next year! 
