Greetings, I hope this letter finds everyone staying safe and getting ready to enjoy the holidays with family and friends. The city council and I would like to wish you all a happy holiday season and a great New Year!

With gift giving in mind, many of you will be ordering packages to be delivered to your home via Amazon, UPS, FedEx, USPS, etc. Our police representative has advised that porch pirates will be out in full force looking to capitalize on easy to grab items. When possible, you may consider choosing other drop off methods such as rear door drop off or require a signature upon delivery. Talk with neighbors about important packages coming in and let's all look out for each other. Should you witness suspicious activity please alert the police immediately.

The city council approved the first reading of the new Code Enforcement Board Ordinance at our November meeting. The proposed Code Enforcement Board would be made up of (3) St. Regis Park residents not currently affiliated with city administrative staff or the city council/ mayor. They will meet at a specified time and location to discuss further action needed for code violations that our citation officer uncovers on regular patrols. Violations which have escalated to an unresolved status after warnings have been issued will be their primary focus.

If the Ordinance is approved by the city council, Code Enforcement Board members will be paid \$25 per meeting hour plus expenses needed to execute the position. For those of you who have expressed interest in code violations that you have found in the city, this is a great opportunity to get involved in the process. Please contact the city or attend next month's meeting at the Jeffersontown Fire Station #2 on December 18th at 7:00pm for more information and discussion.

Recently we have had residents request an avenue to bring code violation issues to our attention anonymously. After some discussion, the council agreed this should be handled by US Mail. Should there be a code violation concern you would like to report to the city without your name being attached, please mail a letter to: City of St.

Regis Park PO Box 20429 Louisville, KY 40250-0429 (also listed at the top of the back page of the newsletter). Also, if you feel uncomfortable to do so, it is not necessary to give your name should you choose to call the citation officer or any other city official.

Following are the Minutes of the November 20, 2024 City Council Meeting for the City of St. Regis Park, held at 7:00 p.m. at the Jeffersontown Fire Station #2.

Ms. Willett made a motion to approve the September and October 2024 financials. The motion was seconded by Mr. Sanderfer, and it passed without dissent.

Mr. Sanderfer made a motion to approve the September and October 2024 meeting minutes. The motion was seconded by Mr. Amback, and it passed without dissent.

Mr. Weis made a motion to approve Municipal Order #1, 2024-2025, an order approving the expenditure of \$2,610.00 for trees at Ascension Church (corner of Lynnbrook and Aintree). The motion was seconded by Mr. Theis and it passed, with Mr. Sanderfer dissenting and Mr. Amback abstaining.

Mr. Weis made a motion to approve the 1st Reading of Ordinance 4, 2024-2025, an ordinance prohibiting cannabis business operations in St. Regis Park. The motion was seconded by Mr. Theis, and it passed without dissent.

Mr. Sanderfer made a motion to approve the 1st Reading of Ordinance 3, 2024-2025, an ordinance establishing a Code Enforcement Board. The motion was seconded by Ms. Willett, and it passed without dissent.

Mr. Sanderfer made a motion to adjourn the meeting. The motion was seconded by M. Lewis, and it passed without dissent. The meeting adjourned at 8:37pm.

Did You Know? 70.02 LIMITATIONS OF STOPPING AND PARKING

(A) No person shall stop or park a vehicle, except when necessary to avoid conflict with other traffic or in compliance with the directions of a police officer or traffic control device, in the following places:

- (1) On a sidewalk or on a driveway blocking a sidewalk;
- (2) In front of a sidewalk ramp providing for handicapped access;
- (3) Within an intersection;
- (4) Within a crosswalk;
- (5) At any place where an official sign prohibits parking;
- (6) Within 30 feet upon the approach to any flashing beacon, stop sign or traffic control signal;
- (7) Within 15 feet of each side of the approach to any fire hydrant;
- (8) Any place the curb is painted red or yellow;
- (9) In any manner that will affect the normal flow of traffic;
- (10) On any bridge, overpass or causeway;
- (11) In front of any public or private driveway;
- (12) In the front, side, street side, or rear of a residence, except on a hard surface of asphalt or concrete;
- (13) Park or stop a vehicle in a space reserved for the handicapped without the proper permit;
- (14) Backed to the curb.
- (B) The maximum number of vehicles permitted on any residential lot in the city shall be:
 - (1) Five passenger vehicles (pick-up trucks, vans and other vehicles not exceeding 6,000 pounds GVW shall be considered as a passenger vehicle); and/or
 - (2) One recreation vehicle (motor home/camper or travel trailer) parked in compliance with this chapter.

Did You Know?

70.01 MANNER OF PARKING

(A) It shall be unlawful for the operator of any vehicle to stop or park the vehicle in a manner other than with its right-hand side toward and parallel with the curb.

(B) No vehicle shall be parked or left standing on any street unless its two right wheels are within one foot of and parallel with the curb, except that on one-way streets where parking is permitted on the left side, the two left wheels are to be within one foot of and parallel with the curb.

Pruning Young Trees

Proper pruning is essential in developing a tree with a strong structure and desirable form. Trees that receive the appropriate pruning measures while they are young will require less corrective pruning as they mature.

Keep these few simple principles in mind before pruning a tree:

- Always have a purpose in mind before making a cut. Each cut has the potential to change the growth of the tree.
- Poor pruning can cause damage that lasts for the life of the tree. Learn where and how to make the cuts before picking up the pruning tools.
- Trees do not heal the way people do. When a tree is wounded, it must grow over the damage. As a result, the wound is contained within the tree forever.
- Small cuts do less damage to the tree than large cuts. Correcting issues when a tree is young will reduce the need for more drastic pruning later.

Making the Cut


Pruning cut location is critical to a tree's growth and wound closure response. Make pruning cuts just outside the branch collar to avoid damaging the trunk and compromising wound responses. Improper pruning cuts may lead to permanent internal decay.

If a large branch must be shortened, prune it back to a secondary branch or a bud. Cuts made between buds or branches may lead to stem decay, sprout production, and misdirected growth.

Pruning Tools

Small branches can be cut easily with hand pruners. Scissor-type or bypass-blade hand pruners are preferred over the anvil type as they make cleaner, more accurate cuts. Cuts larger than one-half inch (1.27 cm) in diameter should be made with lopping shears or a pruning saw.


Hedge shears should be used for shaping hedges only. Do not use shears to prune a tree. Whatever tool you use, make sure it is kept clean and sharp.



Establishing a Strong Scaffold Structure

A good structure of primary branches should be established while the tree is young. These limbs, called scaffold branches, are a mature tree's framework. Properly trained young trees will develop a strong structure that requires less corrective pruning as they mature. The goal in training young trees is to establish a strong, central trunk with sturdy, well-spaced branches. This form mimics tree growth in forest settings where outward branching is limited by neighboring trees.

Some tree species develop some or all of these characteristics naturally, even when grown openly in an urban or park setting. Others may require more frequent attention.

For most young trees, maintain a single dominant leader growing upward. Do not prune back the tip of this leader or allow secondary branches to outgrow the main leader. Sometimes, a tree will develop double leaders known as codominant stems. Codominant stems can lead to structural weaknesses, so it is best to remove or shorten one of the stems while the tree is young.

A tree's secondary branches contribute to the development of a sturdy, well-tapered trunk. When numerous branches are being removed, it is preferable to retain some, at least temporarily, to promote trunk diameter growth.

Permanent Branch Selection

Most of the branches present on a young tree at planting will be pruned away at maturity to provide clearance for mowing, pedestrians, and/ or vehicle traffic.

The height of the lowest permanent branch is determined by the tree's intended function and location in the landscape. The road side of a street tree may be raised to 16 feet (5 m) to accommodate traffic. In most other situations, 8 feet (2.4 m) of clearance is sufficient. Trees used as screens or wind breaks, however, usually branch low to the ground.

Sufficient branch spacing and balance, both vertically and radially, is important. The space between permanent branches should be approximately 3 percent of the tree's eventual height (for example, 1.5 feet [0.5 m] for a tree that can grow to be 50 feet [15 m] tall).

Beyond spacing, the strength of branch structure depends on the relative size of the branches and branch angles. Branches similar in diameter to the trunk or limb from which they arise are more prone to failure than those smaller in diameter.

Narrow angles of attachment or tight crotching can enclose bark within a branch union. Such growth is called included bark, a condition that weakens the branch attachment and may lead to failure when the tree matures. Branches with weak attachments should be pruned while still small. Balance should be considered by retaining some branches in each direction radially, spreading from the center outward. Make sure one scaffold branch is not allowed to grow directly above another.

When pruning, be sure not to remove too many branches. Leaves and their supporting branches are major sites of food production and storage. Eliminating too much of the canopy can "starve" the tree, reduce growth, and increase stress. No more than 25 percent of the crown should be removed in one pruning.

Newly Planted Trees

Pruning of newly planted trees should be limited to the removal of dead or broken branches. All other pruning should be withheld until the second or third year, when a tree has recovered from the stress of transplanting.

Wound Dressings

Despite any claims otherwise, research has shown that wood dressings do not reduce decay or speed wound closure and rarely prevent insect or disease infestations. Most experts recommend that wound dressing not be used.
