Greetings residents. After the brutal winter that mother nature dealt us in January and February, we are glad to see the arrival of Spring! If you are like me, you are looking forward to getting out, working in the yard, and maybe considering more extensive improvement projects. If so, please remember to contact City Councilman, Matt Sanderfer to request a "Letter of Compliance".

You do not need a letter of compliance to replace existing conditions with the same footprint. This includes roof, fence, deck, and driveway replacements. It does not hurt to call Matt, just to make sure. His number can be found on the back page of each newsletter.

With Spring in mind, we will see a significant increase in the number of pedestrians and bike riders on our streets. I can't stress how important it is that we all remain vigilant while driving through the neighborhood to ensure everyone stays safe by staying alert, not speeding, and stopping at our stop signs. We have heard reports from residents of close encounters with moving vehicles at intersections. Thank you in advance for your help with this effort to keep everyone safe.

Our sanitation contract was discussed at the February council meeting. The contract with our current provider, Rumpke, was signed in July 2023 which guaranteed a rate of \$335.45/year per household for two years with an option to increase to \$359.52/year in July 2025 - good till July 2027. The council voted unanimously to accept this option as this pricing is competitive for the service level we request. As a result, you will see a slight increase in your sanitation fee on the property tax bill that you will receive from St. Regis Park for 2025.

Rumpke is currently the only provider in Louisville offering rear door pick-up. Also, we have had very few service issues while working with them for many years. Those of you taking advantage of rear door service, please remember that our contract only allows for pick-up of up to (2) 30-gallon trash receptacles rear door. Big brown cans, green recycling cans, and yard waste must be taken to the end of your driveway for pick-up. If you have experienced service above and beyond what I have outlined, that's great, but please don't assume that level of service is part of our contract.

Many of us living in the original section of the neighborhood, with above ground power and phone lines have been waiting years for high-speed fiber internet

service to become available. I'm happy to report that, by the time you read this newsletter, AT&T fiber should be available to you.

I'm also pleased to announce that we have been approached by another provider, Lumos Fiber, to install service in St. Regis Park. Their representative was on hand at our meeting to talk with us about their service and how the plan would be accomplished. Given the unobtrusive nature of the installation, the council voted unanimously to grant franchise rights to Lumos. The additional competition should help to keep our rates reasonable and will increase the city's yearly revenue through annual franchise fees. Stay tuned for future information on when Lumos will be available for purchase.

Finally, it is time again for the annual "St. Regis Park Easter Egg Hunt!". Please see the flyer in this newsletter. This well attended event is open to all children in St. Regis Park and their guests. It will be held in the back parking lot of St. Andrews United Church of Christ at 2608 Browns Lane (next to Greathouse School) on Saturday April 12th at 10:00 AM. The Easter Bunny will make an appearance. We look forward to seeing you there!

Did You Know?

71.04 QUALIFICATIONS FOR OPERATION OF GOLF CARTS AND ALL-TERRAIN VEHICLES ON CITY STREETS

(A) A golf cart or ATV operating on a city street shall be insured in compliance with KRS 304.39-080 by the owner or operator, and the proof of insurance shall be inside the vehicle at all times of operation on a city street.

(B) Any person operating a low-speed vehicle on a city street shall be subject to the traffic regulations of KRS Chapter 189.

(C) A golf cart or ATV operated on a city street shall:

(1) Prior to seeking a city permit, be inspected by a certified inspector designated by the County Sheriff, and certified through the Department of Vehicle Regulation to ensure that the vehicle complies with the requirements of KRS 189.286. The inspection fee under this section shall not exceed \$5 with an additional fee not to exceed \$10 per trip charged if it becomes necessary for the certified inspector to travel to the site of the golf cart rather than having the golf cart brought to the Sheriff's inspection area.

(2) Be issued a sticker or permit for the golf cart or ATV by the city. The fee for an initial permit or sticker for low-speed vehicle from the city shall be \$25. A permit shall be valid until the first day of March of the following year. The fee for a renewal permit or sticker from the city shall be \$15; and

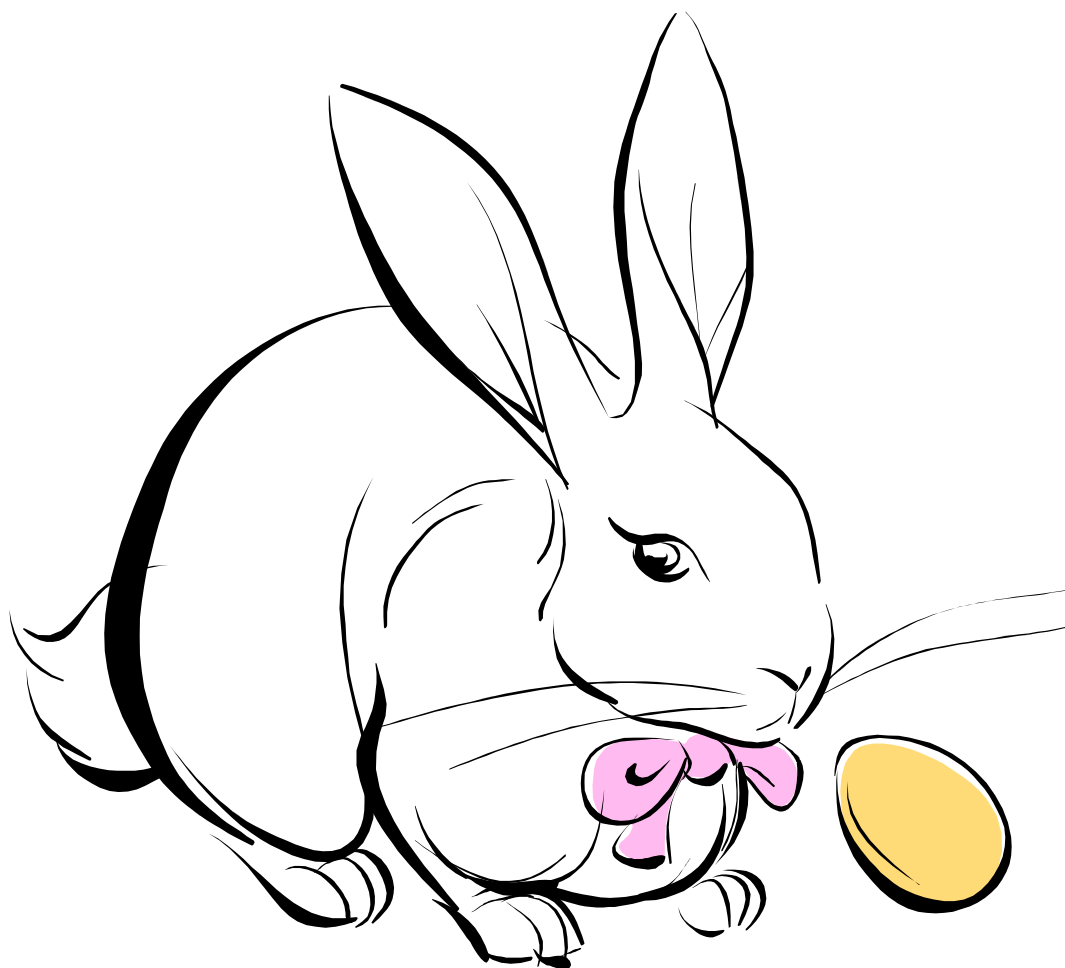
(3) Display the permit or sticker issued by the city on the front of the vehicle that identifies that the golf cart or ATV is allowed to be operated on city streets.

INDEPENDENT AUDITOR'S REPORT

To the Honorable Mayor and City Council
City of St. Regis Park, Kentucky

Report on the Audit of the Financial Statements

Opinions

We have audited accompanying the financial statements of the governmental activities and each major fund, of the City of St. Regis Park, Kentucky, as of and for the year ended June 30, 2024, and the related notes to the financial statements, which collectively comprise the City of St. Regis Park, Kentucky's basic financial statements as listed in the table of contents.

In our opinion, the financial statements referred to above present fairly, in all material respects, the respective financial position of the governmental activities and each major fund of the City of St. Regis Park, Kentucky as of June 30, 2024, and the respective changes in financial position for the City of St. Regis Park, Kentucky for the year then ended in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinions

We conducted our audit in accordance with auditing standards generally accepted in the United States of America (GAAS) and the standards applicable to financial audits contained in *Government Auditing Standards*, issued by the Comptroller General of the United States. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the City of St. Regis Park, Kentucky and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinions.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the City of St. Regis Park, Kentucky's ability to continue as a going concern for twelve months beyond the financial statement date, including any currently known information that may raise substantial doubt shortly thereafter.

Auditor's Responsibilities for the Audit of the Financial Statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinions. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS and *Government Auditing Standards* will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS and *Government Auditing Standards*, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the City of St. Regis Park, Kentucky's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the City of St. Regis Park, Kentucky's ability to continue as a going concern for a reasonable period of time.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Required Supplementary Information

Management has omitted Management's Discussion and Analysis that accounting principles generally accepted in the United States of America require to be presented to supplement the basic financial statements. Such missing information, although not a part of the basic financial statements, is required by the Governmental Accounting Standards Board, who considers it to be an essential part of financial reporting for placing the basic financial statements in an appropriate operational, economic, or historical context. Our opinion on the basic financial statements is not affected by this missing information.

Accounting principles generally accepted in the United States of America require that the management's budgetary comparison information on pages 24-26 be presented to supplement the basic financial statements. Such information is the responsibility of management and, is required by the Governmental Accounting Standards Board, who considers it to be an essential part of financial reporting for placing the basic financial statements in an appropriate operational, economic, or historical context. We have applied certain limited procedures to the required supplementary information in accordance with auditing standards generally accepted in the United States of America, which consisted of inquiries of management about the methods of preparing the information and comparing the information for consistency with management's responses to our inquiries, the basic financial statements, and other knowledge we obtained during our audit of the basic financial statements. We do not express an opinion or provide any assurance on the information because the limited procedures do not provide us with sufficient evidence to express an opinion or provide any assurance.

Other Reporting Required by *Government Auditing Standards*

In accordance with *Government Auditing Standards*, we have also issued our report dated January 28, 2025 on our consideration of the City of St. Regis Park, Kentucky's internal control over financial reporting and on our tests of its compliance with certain provisions of laws, regulations, contracts, and grant agreements and other matters. The purpose of that report is solely to describe the scope of our testing of internal control over financial reporting and compliance and the results of that testing, and not to provide an opinion on the effectiveness of the City of St. Regis Park, Kentucky's internal control over financial reporting or on compliance. That report is an integral part of an audit performed in accordance with *Government Auditing Standards* in considering City of St. Regis Park, Kentucky's internal control over financial reporting and compliance.

ORDINANCE 6, 2024-2025
AN ORDINANCE AMENDING ORDINANCE 31.38**

WHEREAS, the City Council has created a Code Enforcement Board, the city needs to revise Ordinance 31.38 to create the Code Enforcement Officer position and

BE IT ORDERED BY THE CITY OF ST. REGIS PARK:

Section 1. Section 31.38 of the Codified Ordinance is hereby repealed and replaced as follows:

31.38 CODE ENFORCEMENT OFFICER

(A) The City Council hereby creates the non-elected city office of Code Enforcement Officer.

The Code Enforcement Officer shall be appointed by the Mayor, with the approval of the City Council, and may be dismissed with the sole authority of the Mayor. The Code Enforcement Officer shall have all the powers and duties as set out under KRS 65.8801 to KRS 65.8839.

(B) The Code Enforcement Officer shall be compensated as set forth from time to time by the

Council, with cost reimbursement and mileage at the current federal rate. Liability insurance covering the duties of the Code Enforcement Officer will be provided at the City's cost. The Code Enforcement Officer will be supplied with an armband identification, a T-shirt and jacket, cellular telephone and business cards and any further equipment the Council determines necessary. In addition, the Code Enforcement Officer will be given forms of warning for warnings, citations, and a log sheet for the activities.

Section 2. This ordinance shall be in effect and in full force from and after its passage, publication, and recording, according to law.
