This year's event will mark 10 years that St Regis has received the *"Tree City USA"* designation. Please join me by thanking Mary Mattingly, Joe Hinkle, and Susan Messerschmidt for their service to our Tree Board. Over 500 trees have been planted and many more maintained under the programs that they have put in place.

Memorial Day weekend will be here before we know it. That means the opening of Upper Highlands Swim Club for the summer. If you are not a member, please consider joining "the pool". This was my favorite place to hang out during the summer months growing up and I am sure your kids and grandkids will love it as well. Our City Engineer, Mark Madison was in attendance for the March council meeting to give us an assessment of road and bridge conditions within St. Regis Park. Upon inspection, all roads were found to be in good and safe condition except for a few areas needing some patching that is common after winter ice and snow. After discussion it was decided to hold off on any paving projects this year.

Street sign and light pole painting was also discussed. This project was proposed in the fall but put on hold until the spring to take advantage of more favorable weather conditions. We will move forward with this in the coming months as we evaluate incoming pricing and the scope of work from interested contractors.

Over the past year or so, we have heard reports from residents regarding neighbors who are believed to be running a business in the neighborhood. St Regis is zoned for residential usage only. Noise, traffic, parking issues, and all other general nuisances a business typically creates is not something any of us want located next to our home. Please be considerate of your neighbors by conducting business that causes these types of problems outside our city limits.

Finally, the *"St. Regis Park Easter Egg Hunt"* will be held at St Andrew United Church of Christ at 2608 Browns Lane on Saturday April 12th at 10:00 AM in the back parking lot next to Greathouse School. Following are the Minutes of the March 19, 2025 City Council Meeting held at the Jeffersontown Fire Station #2.

Ms. Willett made a motion to approve the February 2025 financials. The motion was seconded by Mr. Weis, and it passed without dissent.

Mr. Sanderfer made a motion to approve the February 2025 meeting minutes. The motion was seconded by Ms. Willett, and it passed without dissent. Ms. Willett made a motion to approve a free three-month ½ page newsletter advertisement for Ascension Church. The motion was seconded by Mr. Weis, and it passed without dissent.

Mr. Weis made a motion to approve a variance for the on-street placement of a dumpster at 4402 St. Regis Lane. The motion was seconded by Mr. Shackelford, and it passed without dissent.

Mr. Sanderfer made a motion to amend the current ordinance, that would allow chickens within the city limits. The motion was seconded by Mr. Shackelford, but the motion failed to pass with the other five (5) council members dissenting. The existing ordinance stands and chickens are not allowed in St. Regis Park.

Ms. Willett made a motion to approve the 2nd Reading of Ordinance 7, 2024-2025, an ordinance establishing a franchise agreement with Lumos Fiber. The motion was seconded by Mr. Sanderfer, and it passed without dissent via a roll-call vote.

Mr. Shackelford made a motion to adjourn the meeting. The motion was seconded by Mr. Sanderfer, and it passed without dissent. The meeting adjourned at 8:35pm.

50.01 PLACEMENT - COLLECTION AND REMOVAL

(A) No garbage, grass or trash shall be placed at the curb side before 3:00 p.m., the day prior to pick up.

(B) All garbage cans and items not collected shall be removed from the curb side by 7:00 p.m., the day of pickup.

(C) During the fall of the year, leaves may be placed at the curbside the day prior to pick up after 3:00 p.m., as provided in division (A).

(D) The placement of garbage, grass, leaves or trash at the curbside shall be near the curb within the property line and not on the street.

Trash Pick-up Day



CITY OF ST. REGIS PARK ORDINANCE ***7**, **2024**. **2025** AN ORDINANCE AUTHORIZING THE MAYOR TO ENTER INTO A UNIFORM FRANCHISE AGREEMENT

WHEREAS, Louisville/Jefferson County Metro Government publicly advertised bid proposals from parties interested in obtaining franchises to erect, install or maintain communication facilities or provide communication services by use of said communication facilities within the confines of Louisville Metro, Kentucky, which includes all the area in Jefferson County, Kentucky,

AND WHEREAS, Lumos Fiber of Kentucky LLC (hereinafter "Provider"), with its principal office located at 4100 Mendenhall Oaks Parkway, Suite 300, High Point, NC 27265, submitted a bid proposal to Louisville Metro for a communications services franchise pursuant to the requirements of Chapter 116 of the Louisville Metro Code of Ordinances and was approved as the winning bidder by the City of Louisville Council meeting of the 12th day of December 2024,

AND WHEREAS, The City of St. Regis Park, being located within the confines of Louisville Metro (Jefferson County), also desires to approve a non-exclusive franchise with Lumos Fiber of Kentucky LLC, since a portion of the project will be located upon rights of way owned by the City of St. Regis Park, but which are still in the geographic area of the bid notice,

NOW THEREFORE, BE IT RESOLVED BY THE CITY OF ST. REGIS PARK, KENTUCKY:

SECTION 1:

That the City of St. Regis Park hereby recognizes, adopts the bid process and all the related findings of Louisville/Jefferson County Metro Government supporting the franchise approval of Lumos Fiber of Kentucky LLC, contained in the record of such approval at the Louisville Metro Council meeting. Further, based on the findings herein, the certain non-exclusive franchise agreement for telecommunication services in Jefferson County, by and between the City of St. Regis Park and Lumos Fiber of Kentucky LLC, be and hereby is approved by the City Council. Further the City Mayor is hereby authorized to sign the Agreement, along with any other documents required to effectuate the terms of the referenced Agreement, attached, and fully incorporated herein as Exhibit One.

SECTION 2:

This Ordinance shall take effect upon its reading, passage, approval, and publication according to law.

Safe Walking Tips

Walk Facing Traffic

If there is no sidewalk and you must walk in the street, choose the side where you are facing oncoming traffic. In the United States, this is the left side of the road. Walking opposite traffic gives you the best chance to see vehicles approaching close to you.

Be Visible

Give drivers every chance to see you by wearing bright-colored clothing during daylight hours. Be especially careful near dawn and dusk when the sun is low and blinding. Wear a reflective vest while walking at night.

Keep the Volume Down

Don't drown out your environment when listening to music with earbuds or headphones. Keep the volume at a level where you can still hear bike bells, approaching vehicles, and warnings from others. If you are using ear buds, consider wearing only one so that you can hear your surroundings.

Hang Up and Eyes Up

Distracted walking due to chatting, texting, or using a mobile device is as dangerous as doing those things while driving. You are distracted and not as aware of your environment. You are less likely to recognize traffic danger, tripping hazards, or passing joggers and bikers.

Walk Dogs on Short Leashes

It is terrifying and tragic to witness dogs running into traffic or getting into a fight. When walking your dog on a long leash there is also a danger that you will trip other walkers or bikers. You will keep your dog safer as well as those who pass by you if you use proper leash walking etiquette.

Teach your Children to be Aware

While on family strolls, never allow your toddlers to run ahead or fall behind. Teach them to avoid unfamiliar animals. Encourage them to be safe pedestrians and make them aware that vehicles might back out of driveways.
